## Valuation for Traditional Retail Insurance Replacement

## Item 1

One lady's, hand-assembled raised, 14ct white gold, 9ct white gold, 18ct white gold & diamond set, flexible link necklet.

Feature, "drop style" four claw 14ct white gold pendant. Housing, one round brilliant cut diamond, claw set. Suspended from a 9ct white gold, fine box linked chain, with an 18ct white gold bolt ring closure attached.

Polished finish, stamped "375, italy (chain), 750 (clasp)" - acid tested & x-rayed, as 9ct, 14ct & 18ct (mixed).

Necklet dimensions = 48.50cm (total length) x 0.63mm (width) x 0.63mm (depth). Pendant dimensions = 10.00mm (length) x 4.23mm (width) x 5.77mm (depth).

The necklet/pendant contains:

One claw set round brilliant cut diamond, clarity is "P1", colour is "I", medium cut quality.

Dimensions = 4.23mm (Diameter) x 2.51mm (D-estimated)

Total Weight = 0.27ct (estimated - see NOTE below).

Total Item Weight = 1.92 grams, Total Gemstone Weight = 0.27ct, Total Metal Weight = 1.87 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weights of the gemstone are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstone require removal from the settings. The below replacement figure is based upon crafting a similar necklet/pendant combo employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
