## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, hand crafted, 18ct yellow gold, multistone, gem set ring.

Plain, wide, tapered band of 12.14mm at top to 3.86mm in width (at base) x 1.21mm depth, with hollow top and open back settings.

Feature 'cushion-shape' setting, housing one round brilliant cut diamond (largest), claw set. Surrounded by eight round brilliant cut diamonds, alternating in size, bead set. Secured between the shoulders of the plain and polished band.



Polished finish - stamped '18CT' - acid tested as 18 carat gold. Finger size is V.

The ring contains:

One claw set round brilliant cut diamond, clarity 'P1', colour 'G'.

Dimensions = 4.35mm(Dia) x 2.65mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.32ct (estimated - see NOTE below)

Eight bead set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G to H' (mixed).

Dimensions = 2.70mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 3.35mm(Dia) x 2.04mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.84ct (estimated - see NOTE below)

Total Item Weight = 13.64 grams - Total Gemstone Weight = 1.16ct - Total Metal Weight = 13.41 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones as very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
