## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand-assembled raised, 18ct yellow and white gold & gemset, multistone ring. Plain, narrow, low half round, tapered band, measures 3.17mm width (at base) x 1.09mm depth, with cut-out underrail, open back setting, underneath.

Feature, "solitaire style" with shoulder stones. Comprising, a raised, white gold four claw railed setting, houses one emerald cut natural sapphire, claw set. The extended shoulders, of the yellow gold band, tapers up to the top. Each shoulder, contains three round brilliant cut diamonds, bead set, both sides.



Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = Q.

The ring contains;

One claw set emerald cut natural sapphire, colour is "very dark blue".  
Dimensions = 7.23mm (L) x 5.26mm (W) x 3.50mm (D-estimated)  
Total Weight = 1.44ct (estimated - see NOTE below).

Six bead set round brilliant cut diamonds, clarity is "P1", colour is "H", medium cut quality.  
Dimensions = 2.75mm (average diameter) x 1.68mm (D-estimated)  
Total Weight = 0.45ct (estimated - see NOTE below).

Total Item Weight = 4.83 grams, Total Gemstone Weight = 1.89ct, Total Metal Weight = 4.45 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
