### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, hand crafted, white gold, multistone, gem set ring.

Plain, wide, tapered band of 3.21mm in width (at base) x 1.32mm depth, with a curved underrail.

Feature three individual four claw railed settings, each housing one emerald cut natural sapphire, claw set. Alternating with four round brilliant cut diamonds, in groups of two, shared claw set. All secured between the extended and upswept shoulders of the plain and polished band.

Polished finish - incorrectly stamped '750' - x-rayed as an average 7 carat gold. Finger size is O.

The ring contains:

Three claw set emerald cut natural sapphires, colour 'dark blue'.

Dimensions = 5.08mm(L) x 3.06mm(W) x 1.84mm(D-estimated) (smallest)

Dimensions = 5.17mm(L) x 3.17mm(W) x 1.90mm(D-estimated) (largest)

Total Weight = 0.96ct (estimated - see NOTE below)

Four claw set round brilliant cut diamonds, clarity 'Vs & Si' (mixed), colour 'G'.

Dimensions (average) = 2.35mm(Dia) x 1.43mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.19ct (estimated - see NOTE below)

Total Item Weight = 5.11 grams - Total Gemstone Weight = 1.15ct - Total Metal Weight = 4.88 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
