Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.78mm width (at base) x 1.04mm depth, with a hollow top and shoulders, open back settings, and a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. Surrounding is three rows with a total of twenty round brilliant cut diamonds, graduating in size, largest to the centre, and claw set. The settings are secured to the underrail, and in between the tapering shoulders of the plain and polished band.



Polished finish. Stamped '9K' - acid tested as 9 carat gold. Ring size: M.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "G"

Dimensions = 3.07mm(Dia) x 1.87mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.12ct (estimated - see NOTE below)

Twenty claw set round brilliant cut diamonds, clarity is "P1 & P2 & P3" (mixed), colour is "G to H" (mixed).

Dimensions = 1.88mm(Dia) x 1.15mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.70mm(Dia) x 1.65mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.88ct (estimated - see NOTE below)

Total Item Weight = 4.01 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 3.81 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
