Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 2.91mm width (at base) x 0.85mm depth.

Feature central white gold illusion plate within a six claw setting, housing one round brilliant cut diamond, illusion set. The central setting and white gold decorative 'leaf' shaped shoulder plates, are secured to the top of the plain and polished yellow gold band. Each of the shoulder plates is embellished with a three claw setting, housing one single cut diamond, claw set.

Polished finish.

Stamped '8CT(partial) 13442(engraved)' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "Si2", colour is "G".

Dimensions = 4.10mm(L) x 4.07mm(W) x 2.48mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.25ct (estimated - see NOTE below)

Two claw set single cut diamonds, clarity is "Vs & Si" (mixed), colour is "G".

Dimensions (average) = 1.30mm (diameter)

Total Weight = 0.02ct (estimated - see NOTE below)

Total Item Weight = 3.48 grams Total Gemstone Weight = 0.27ct Total Metal Weight = 3.43 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
