Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold, gem set, 'three stone' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.74mm width (at base) x 1.48mm depth, with open back settings, and a curved underrail.

Feature central four double claw setting, housing one emerald cut natural aquamarine, claw set. Each of the shoulders houses one baguette cut diamond, end set. The settings are secured to the underrail, and in between the extended and square shoulders, of the plain and polished band.



Polished finish. Stamped '14K' - acid tested as 14 carat gold. Ring size: M 1/2.

The ring contains:

One claw set emerald cut natural aquamarine, colour is "blue".

Dimensions = 9.04mm(L) x 7.11mm(W) x 4.68mm(D-estimated)

Total Weight = 2.05ct (estimated - see NOTE below)

Two end set baguette cut diamonds, clarity is "Vs", colour is "G".

Dimensions (average) = 4.00mm(L) x 2.15mm(W) x 1.53mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.20ct (estimated - see NOTE below)

Total Item Weight = 4.00 grams Total Gemstone Weight = 2.27ct Total Metal Weight = 3.55 grams (estimated)

NOTE: The central gemstone has significant abrasion to the table facet, and has been priced accordingly. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does no represent the previous selling price of the item and will not be indicative of the resale value of the item.
