Valuation for Traditional Retail Insurance Replacement

One pair of, 18ct white gold, gem set, drop stud style earrings, of hand-assembled construction.

Feature central 'flower' style stud top, comprising a central round glass (paste) type material, bezel set, surrounded by one row of six round natural garnets, claw set. To the bottom of the stud, is an articulated natural garnet briolette drop, drill set. The earrings are finished with a post and butterfly attachments.

Earring dimensions = 30.00mm (ave. length) x 9.25mm (ave. width).

Polished finish.

Stamped '750' - acid tested as 18 carat gold.

The earrings contain:

Six claw set round natural garnets, colour is "red".

Dimensions (average) = 3.05mm(Dia) x 1.86mm(D-estimated)

Total Weight = 0.72ct (estimated - see NOTE below)

Two bezel set round glass (paste) type material, colour is "yellow".

Dimensions (average) = 3.30mm(Dia) x 2.01mm(D-estimated)

Total Weight = 0.20ct (estimated - see NOTE below)

Two drill set briolette cut pear shaped natural garnets, colour is "red".

Dimensions (average) = 10.50mm(L) x 7.05mm(W)

Total Weight = 6.00ct (estimated - see NOTE below)

Total Item Weight = 4.07 grams Total Gemstone Weight = 6.92ct Total Metal Weight = 2.69 grams (estimated)
