## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, 18ct white gold, multistone, ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.20mm width (at base) x 1.51mm depth, with open back settings.

Feature stylised 'flower' ring, with a central three claw setting, housing one round brilliant cut diamond, claw set. Surrounding is several open style 'petals', each housing one row of round brilliant cut diamonds, graduating in size, and bead set. There are a total of sixty-two round brilliant cut diamonds. The design lengthens out from the extended and pointed shoulders, of the plain and polished band.



Polished finish. Stamped 'CHANEL 750 S15661 55 unknown makers'. Assayed in France - acid tested as 18 carat gold. Ring size: O.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs", colour is "G".

Dimensions = 3.40mm(Dia) x 2.07mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.15ct (estimated - see NOTE below)

Sixty Two bead set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G".

Dimensions = 0.84mm(Dia) x 0.51mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.65mm(Dia) x 1.01mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.48ct (estimated - see NOTE below)

Total Item Weight = 5.92 grams
Total Gemstone Weight = 0.63ct

Total Metal Weight = 5.79 grams (estimated)

NOTE: The ring has a stamp of Chanel upon. Authentication by a Melbourne agent of Chanel would be required. Therefore, due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
