Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'three stone' style ring, of hand-assembled construction.

Plain, narrow, flat, tapered band of 3.03mm width (at base) x 0.87mm depth.

Feature white gold illusion plate within a six claw setting, housing one round brilliant cut diamond, illusion set. The setting is secured to the top of the plain and polished yellow gold band, and in between the decorative white gold shoulder plates. Each of the shoulder plates is embellished with one three claw setting, housing one round brilliant cut diamond, claw set.

Polished finish.

Stamped '13445 18CT T' - acid tested as 18 carat gold.

Ring size: N.

The ring contains:

One illusion set round brilliant cut diamond, clarity is "Vs", colour is "G".

Dimensions = 4.16mm(L) x 4.14mm(W) x 2.53mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.25ct (estimated - see NOTE below)

Two claw set single cut diamonds, clarity is "Si", colour is "G".

Dimensions (average) = 1.50mm (diameter)

Total Weight = 0.03ct (estimated - see NOTE below)

Total Item Weight = 3.71 grams Total Gemstone Weight = 0.28ct Total Metal Weight = 3.65 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
