## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, gem set, 'three stone' style dress ring, of handmade construction.

Plain, narrow, half round, tapered band of 3.15mm width (at base) x 1.36mm depth, with open back settings, and a curved underrail.

Feature central bezel setting, housing one freeform solid opal, bezel set. The central setting is secured between the shoulders of the plain and polished band. The shoulders are embellished with a white gold bezel setting, each housing one round brilliant cut diamond, bezel set.

Polished finish.

Stamped '18ct' - acid tested as 18 carat gold.

Ring size: M.

The ring contains:

One bezel set freeform natural white opal cabochon, with "green, blue, and violet" play of colours.

Dimensions = 12.10mm(L) x 9.01mm(W) x 4.65mm(D-estimated)

Total Weight = 2.90ct (estimated - see NOTE below)

Two bezel set round brilliant cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 3.25mm(Dia) x 1.98mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 8.00 grams Total Gemstone Weight = 3.16ct Total Metal Weight = 7.37 grams (estimated)

NOTE: The central opal is severely abraded, and requires re-polishing. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
