Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct white gold, gem set, multistone ring, of cast construction.

Plain, narrow, low half round band of 1.46mm width (at base) x 1.06mm depth, with open back settings, and a curved underrail.

Feature three, four claw settings, each housing one emerald cut diamond, graduating in size, largest to the centre, claw set. The settings are secured in between the extended and square shoulders, of the plain and polished band. Each of the shoulders house one row of four round brilliant cut diamonds, claw set.



Polished finish.

Stamped '10KT.50 TDW michael hill' - acid tested as approximately 10 carat gold.

Ring size: O.

The ring contains:

One claw set emerald cut diamond, clarity is "Si1", colour is "G".

Dimensions = 3.90mm(L) x 2.83mm(W) x 1.83mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.18ct (estimated - see NOTE below)

Two claw set emerald cut diamonds, clarity is "Sil", colour is "G".

Dimensions = 3.17mm(L) x 2.31mm(W) x 1.73mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.24ct (estimated - see NOTE below)

Eight claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "G".

Dimensions (average) = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.08ct (estimated - see NOTE below)

Total Item Weight = 1.73 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 1.63 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings.
