One, 14ct white gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.76mm width (at base) x 1.21mm depth.

Feature central six claw setting, housing one round brilliant cut diamond, claw set. The setting, underrail and shoulders are embelllished with a total of thirty-six round brilliant cut diamonds, varying in size, and claw set. Underneath the central setting is one round ruby, gypsy set. The settings are secured between the shoulders of the plain and polished band.
