Valuation for Traditional Retail Insurance Replacement

Item 1

One, 18ct yellow gold, gem set, multistone ring, of hand-assembled construction.

Plain, narrow, low half round band of 1.86mm width (at base) x 0.99mm depth, with open back settings.

Feature five channel settings, spanning across the top of the band, each housing one round brilliant cut diamond, end set. The settings are secured between the extended and square shoulders, of the plain and polished band.



Polished finish.

Stamped '18K' - acid tested as 18 carat gold.

Ring size: L.

The ring contains:

Five end set round brilliant cut diamonds, clarity is "Vs & Si" (mixed), colour is "G to H" (mixed).

Dimensions = 3.61mm(L) x 3.58mm(W) x 2.18mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.85ct (estimated - see NOTE below)

Total Item Weight = 3.57 grams Total Gemstone Weight = 0.85ct Total Metal Weight = 3.40 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones a very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
