### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 9ct white gold, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.10mm width (at base) x 0.99mm depth, with a curved underrail.

Feature central four claw decorative setting, housing one Princess cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped '375 GM16 D050' - acid tested as 9 carat gold.

Ring size: M.

The ring contains:

One claw set Princess cut diamond, clarity is "Vs", colour is "K".

Dimensions = 4.33mm(L) x 4.25mm(W) x 3.35mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.42 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 2.32 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting.
