## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 9ct yellow gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 2.05mm in width (at base) x 0.60mm depth, with hollow top and open back settings.

Feature double row ring design, consisting of four round brilliant cut diamonds, channel set in groups of two to one raised row. The remaining row houses twenty-seven tapered baguette cut diamonds, also channel set.

Polished finish - stamped '375' - acid tested as 9 carat gold. Finger size is R 1/2.

The ring contains:

Four channel set round brilliant cut diamonds, clarity 'P1 & P2' (mixed), colour 'G'.  
Dimensions (average) = 1.70mm(Dia) x 1.04mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.08ct (estimated - see NOTE below)

Twenty Seven channel set tapered baguette cut diamonds, clarity 'Vs, Si & P1' (mixed), colour 'I to J' (mixed).  
Dimensions (average) = 1.76mm(L) x 0.85mm(W) x 0.56mm(D-estimated) x 2%(Girdle Thickness)  
Total Weight = 0.25ct (estimated - see NOTE below)

Total Item Weight = 2.84 grams - Total Gemstone Weight = 0.33ct - Total Metal Weight = 2.77 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
