## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's, hand finished, raised 14ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 1.21mm width (at base) x 0.82mm depth, with curved underrail, hollowed out shoulders.

Features, "illusion style cluster". Comprising, a raised four claw setting, housing nine Princess cut diamonds, grouped together, illusion claw set to the angle. The extended shoulders, of the band, tapers up, each side forming two of the claws, to each side.

Polished finish, stamped "585" - acid tested as 14 carat gold.

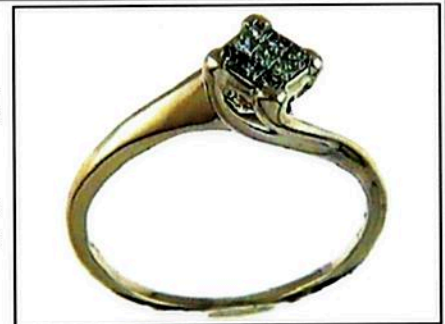
Finger size = O1/2.

The ring contains;

Nine illusion claw set Princess cut diamonds, clarity is "Si & P1"(mixed), colour is "G to H"(mixed), medium cut quality.  
Average dimensions = 1.45mm (L) x 1.45mm (W) x 1.03mm (D-estimated)  
Total Weight = 0.15ct (estimated - see NOTE below).

Total Item Weight = 2.60 grams, Total Gemstone Weight = 0.15ct, Total Metal Weight = 2.57 grams (estimated)

NOTE: Limited gemmological testing, inset, Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
