One lady's, hand finished, raised 14ct white gold & diamond set, solitaire ring. Plain, narrow, flat, low half round, tapered band, measures, 1.75mm width (at base) x 1.00mm depth, with curved underrail.

Feature, "solitaire style" ring design. Comprising, a raised, four claw setting, to top, houses one round brilliant cut diamond (laser inscribed), claw. The extended shoulders, of the band tapers up to pointed end terminations, to both sides.



Finger size = N.

The ring contains;

One claw set round brilliant cut diamond, clarity is "Si2", colour is "E", good cut quality. Dimensions = 3.91 - 3.88mm (diameter) x 2.47mm (D-estimated) x 5%(Girdle Thickness) Total Weight = 0.24ct (actual - see NOTE below).

Total Item Weight = 2.60 grams, Total Gemstone Weight = 0.24ct, Total Metal Weight = 2.55 grams (estimated)

The diamond has also been laser inscribed upon the girdle with HRD (logo) and ID210000022471.
