## Valuation for Traditional Retail Insurance Replacement

### Item 1

One lady's, hand finished, raised 9ct yellow gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 2.24mm width (at base) x 1.05mm depth, with open back, settings underneath.

Feature, "cluster style" design. Comprising, a pear-shaped cluster setting to centre. eight diamonds, grouped claw set. Drops to an open surround, containing twenty single cut diamonds, claw set. The extended shoulders, of the band tapers up to the top, from both sides.

Polished finish, stamped "9ct A&C JP146" - acid tested as 9 carat gold. Finger size O1/2.

The ring contains;

Seven claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "tint light brown ", medium cut quality.

Dimensions = 1.70mm (average diameter) x 1.04mm (D-estimated)

Total Weight = 0.13ct (estimated - see NOTE below).

Twenty One claw set single cut diamonds, clarity is "Si & P1"(mixed), colour is "tint light brown".

Dimensions = 0.91mm (average diameter) (smallest)

Dimensions = 1.32mm (average diameter) (largest)

Total Weight = 0.17ct (estimated - see NOTE below).

Total Item Weight = 2.10 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 2.04 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
