Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, hand finished, raised 10ct white gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.80mm width (at base) x 1.08mm depth, with underrail.

Feature, "cluster style" ring design. Comprising, a stepdown round cluster setting to top, contains twenty eight round brilliant cut diamonds, tapering sizes, all claw set. The extended shoulders, of the band, tapers up to the top, from both sides.

Polished finish, stamped "MHJ (faded)" - acid tested & x-rayed approximately 10 carat gold.

Finger size = L.

Six claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "G to H"(mixed), medium cut quality.
Dimensions = 2.40mm (average diameter) x 1.46mm (D-estimated)
Total Weight = 0.30ct (estimated - see NOTE below).

Twenty Two claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.23mm (average diameter) x 0.75mm (D-estimated) (smallest)
Dimensions = 1.61mm (average diameter) x 0.98mm (D-estimated) (largest)
Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 2.70 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 2.60 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only.
