## Valuation for Traditional Retail Insurance Replacement

## Item 1

One lady's, hand-assembled raised, 18ct yellow and white gold, gemstone set, cluster ring. Plain, narrow, low half round, tapered band, measures 2.07mm width (at base) x 1.56mm depth, with open back, settings underneath.

Feature, "cluster style" ring design. Comprising a raiused white gold cluster setting, houses one round, faceted, natural sapphire to centre, claw set. Drops to a wire basket surround, containing twelve single cut diamonds, claw set. The extended shoulders, of the yellow gold band, tapers & sweeps up to pointed end terminations, to both sides.



Polished finish, hallmarked "S&D 750, Assay - Birmingham UK Circa 1975" Starlight.

Acid tested as 18 carat gold. Finger size = K.

The ring contains;

One claw set round cut, faceted, natural sapphire, colour is "medium dark, blue - bluish green".

Dimensions = 5.99mm (Diameter) x 4.08mm (D-estimated)

Total Weight = 1.10ct (estimated - see NOTE below).

Twelve claw set single cut diamonds, clarity is "Vs & Si"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.04mm (average diameter)

Total Weight = 0.40ct (estimated - see NOTE below).

Total Item Weight = 4.10 grams, Total Gemstone Weight = 1.50ct, Total Metal Weight = 3.80 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
