Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, (2 pce set fused as one), hand-assembled raised, 18ct yellow gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.87mm width (at base) x 0.91mm depth, with curved underrail.

Feature, "cluster style" ring design (fused together). Comprising, a raised six claw setting, drops to one side, three four claw settings. The extended shoulders, of the band, tapers up to the top, from both sides.

Polished finish, stamped "18ct" - acid tested as 18 carat gold. Finger size = K.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P1", colour is "brown tint", medium cut quality.
Dimensions = 4.58mm (Diameter) x 2.79mm (D-estimated)
Total Weight = 0.36ct (estimated - see NOTE below).

Three claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "light brown tint".
Dimensions = 2.30mm (average diameter) x 1.40mm (D-estimated)
Total Weight = 0.14ct (estimated - see NOTE below).

Total Item Weight = 4.50 grams, Total Gemstone Weight = 0.50ct, Total Metal Weight = 4.40 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar fused ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
