Valuation for Traditional Retail Insurance Replacement

Item 1

One, hand-assembled, 9ct white gold, multistone, gem set ring. Plain, narrow band of 1.82mm in width (at base) x 1.11mm depth, with a curved underrail.

Feature central four claw setting, consisting of an illusion setting, housing one round brilliant cut diamond, illusion set. Surrounded by twelve single cut diamonds (smallest), claw set. The outer row having sixteen single cut diamonds, slightly larger, claw set. Four claw base support, with a double ring 'loop' style design above the underrail. All secured between the extended shoulders of the plain and polished band. Each shoulder having shared claw settings, consisting of illusion settings, each housing three single cut diamonds and one round brilliant cut diamond, illusion set.



Polished finish - stamped '375 JP02' - acid tested as 9 carat gold. Finger size is O.

The ring contains:

One illusion set round brilliant cut diamond, clarity 'P1', colour 'H'.

Dimensions = 2.18mm(Dia) x 1.33mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.04ct (estimated - see NOTE below)

Thirty Six claw set & illusion set (mixed) single cut diamonds, clarity 'Si, P1 & P2' (mixed), colour 'I to K' (mixed).

Dimensions = 1.10mm(Dia) (smallest)

Dimensions = 1.25mm(Dia) (largest)

Total Weight = 0.21ct (estimated - see NOTE below)

Total Item Weight = 2.29 grams - Total Gemstone Weight = 0.25ct - Total Metal Weight = 2.24 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
