Valuation for Traditional Retail Insurance Replacement

Item 1

One, platinum and 18ct rose gold, diamond set, multistone, 'cluster' style ring, of handassembled construction.

Plain, narrow, half round band of 2.24mm width (at base) x 1.66mm depth, with open back settings, and a curved underrail.

Feature central pear shaped platinum top plate, with a central three claw setting, housing one pear shaped diamond, claw set. Surrounding is one row of nineteen round brilliant cut diamonds, claw set. The top plate is secured to the underrail and in between two rose gold 'leaf' shaped shoulder plates, each housing one round brilliant cut pink diamond, bead set. The settings are secured to the top of the plain and polished platinum band.



Polished finish. Stamped '750 PT 950 M 5413096775' - acid tested as platinum and 18 carat gold. Ring size: N 1/2.

The ring contains:

One claw set pear shaped diamond, clarity is "Si1", colour is "G".

Dimensions = 6.83mm(L) x 4.40mm(W) x 2.71mm(D-estimated) x 2.5%(Girdle Thickness)

Total Weight = 0.50ct (known weight - see NOTE below)

Nineteen claw set round brilliant cut diamonds, clarity is "Si", colour is "G".

Dimensions = 1.00mm(Dia) x 0.62mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Two bead set round brilliant cut diamonds, clarity is "Si", colour is "FLP" (fancy light pink).

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.06ct (estimated - see NOTE below)

Total Item Weight = 5.33 grams Total Gemstone Weight = 0.76ct Total Metal Weight = 5.18 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 5413096775 Dated: December 02, 2021. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 5413096775. The certificate of authenticity was presented by pink caviar, australian argyle pink diamonds, Model number: 2469V50PA, Argyle lot number: 1686507. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
