Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold and rhodium plated, diamond set, multistone, 'cluster' style ring, of hand-assembled construction. Plain, narrow, low half round, tapered band of 2.54mm width (at base) x 0.99mm depth, with a hollow top and shoulders, open back settings and a cut out underrail.

Feature white gold square top plate within a four claw setting, housing nine round brilliant cut diamonds, largest to the centre, and claw set. The setting is secured to the underrail and in between the extended and square shoulders of the plain and polished yellow gold band. Each of the shoulders houses twelve tapered baguette cut diamonds, graduating in size, largest to the centre, and channel set. There are two rails either side of the central setting, each housing one row of fifteen single cut diamonds, graduating in size, and channel set. Rhodium plating to the setting areas.



Polished finish. Stamped '9K 0.50CT' - acid tested as 9 carat gold. Ring size: Q.

The ring contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "I".

Dimensions = 2.66mm(Dia) x 1.62mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.07ct (estimated - see NOTE below)

Thirty Eight channel, bead, and claw set round brilliant cut and single cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to I" (mixed).

Dimensions = 0.90mm(Dia) 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.93mm(Dia) x 1.18mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.19ct (estimated - see NOTE below)

Twenty Four channel set tapered baguette cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 1.50mm(L) x 0.83mm(W) x 0.61mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.77mm(L) x 0.85mm(W) x 0.62mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.24ct (estimated - see NOTE below)

Total Item Weight = 3.58 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 3.48 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. Th below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of th item.
