## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, platinum, synthetic laboratory grown diamond, 'solitaire' style ring, of cast construction.

Plain, narrow, knife edge band of 2.23mm width (at base) x 1.77mm depth, with a curved underrail.

Feature central four claw setting, housing one Princess cut synthetic laboratory grown diamond, claw set. The setting is secured between the extended and pointed shoulders of the plain and polished band.



Polished finish.

Stamped 'PT 950' - acid tested as platinum.

Ring size: I.

The ring contains:

One claw set Princess cut synthetic laboratory grown diamond, clarity is "VVS2", colour is "F". Dimensions = 5.26mm(L) x 5.22mm(W) x 3.71mm(D-estimated) x 6%(Girdle Thickness) Total Weight = 0.94ct (known weight - see NOTE below)

Total Item Weight = 4.28 grams Total Gemstone Weight = 0.94ct Total Metal Weight = 4.09 grams (estimated)

NOTE: The diamond has been certified by and is the opinion of Messrs. International Gemological Institute, Certificate no. LG502138440 Dated 11/19/2021. The diamond has also been laser inscribed upon the girdle with IGI (logo) and LABGROWN LG502138440. No diamond certificate or paperwork was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstone cannot be ascertained. Therefore, weight of the gemstone is very much an estimation. For an accurate weight, colour, and clarity grading, the gemstone requires removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
