Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct yellow gold and 9ct white gold and rhodium plated, diamond set, multistone pendant of hand-assembled construction.

Feature round top plate with a central white gold illusion plate within a four claw setting, housing one round brilliant cut diamond, illusion set. Surrounding is one row of twelve round brilliant cut diamonds, claw set. The pendant is finished with an articulated tapered bail. Rhodium plating to the setting areas.

Pendant dimensions = 15.00mm (ave. length) x 9.00mm (ave. width) x 5.29mm (ave. depth).

Polished finish.

Unstamped - acid tested as 9 carat gold.

The pendant contains:

One illusion set round brilliant cut diamond, clarity is "P2", colour is "H".

Dimensions = 3.25mm(Dia) x 1.98mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.13ct (estimated - see NOTE below)

Twelve claw set round brilliant cut diamonds, clarity is "P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions (average) = 1.75mm(Dia) x 1.07mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.26ct (estimated - see NOTE below)

Total Item Weight = 1.20 grams Total Gemstone Weight = 0.39ct Total Metal Weight = 1.12 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
