## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, 18ct yellow gold and 18ct white gold, diamond set, multistone, 'cluster' style ring, of hand-assembled construction.

Plain, narrow, low half round, tapered band of 2.096mm width (at base) x 1.27mm depth, with open back settings.

Feature square white gold top plate, within a four claw setting, housing four Princess cut diamonds, invisibly set. The top plate is supported with a decorative gallery, and is secured between the extended and square shoulders, of the plain and polished yellow gold band. Each of the shoulders has one row of four Princess cut diamonds, graduating in size, and channel set.

Polished finish. Stamped 'iS 18K 750 MHJ 1.00 TDW' - acid tested as 18 carat gold. Ring size: S 1/2.

#### The ring contains:

Six invisibly and channel set Princess cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions (average) = 2.60mm(L) x 2.60mm(W) x 1.85mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.60ct (estimated - see NOTE below)

Six channel set Princess cut diamonds, clarity is "Si", colour is "H to I" (mixed).

Dimensions = 1.95mm(L) x 1.95mm(W) x 1.38mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.29mm(L) x 2.29mm(W) x 1.63mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.40ct (estimated - see NOTE below)

Total Item Weight = 4.97 grams Total Gemstone Weight = 1.00ct Total Metal Weight = 4.77 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
