## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's hand finished, raised 9ct white gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures, 1.97mm width (at base) x 0.75mm depth, with underrail. Feature, illusion style step down cluster to top. The extended shoulders, of the band, tapers up to the top, each shoulder diamond, claw set.

Polished finish, stamped "375, JP88" - acid tested as 9 carat gold. Finger size = R.

The ring contains;

Four illusion claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.46mm (average diameter) x 1.50mm (D-estimated)

Total Weight = 0.22ct (estimated - see NOTE below).

Twenty Nine claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 1.15mm (average diameter) x 0.70mm (D-estimated) (smallest)

Dimensions = 1.55mm (average diameter) x 0.95mm (D-estimated) (largest)

Total Weight = 0.29ct (estimated - see NOTE below).

Four claw set round brilliant cut diamonds, clarity is "P1 & P2"(mixed), colour is "G to H"(mixed), medium cut quality.

Dimensions = 1.02mm (average diameter) x 0.62mm (D-estimated)

Total Weight = 0.02ct (estimated - see NOTE below).

Total Item Weight = 2.44 grams, Total Gemstone Weight = 0.53ct, Total Metal Weight = 2.33 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
