Valuation for Traditional Retail Insurance Replacement

One, lady's hand-assembled raised, 18ct yellow and white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.77mm width (at base) x 1.32mm depth, with curved underrail.

Feature, "illusion cluster" style ring design, with shoulder stones. Comprising, a raised four claw cluster setting to top, houses ten roynd brilliant cut diamonds, illusion claw set. The extended shoulders, of the yellow gold band tapers up to pointed end terminations, to both sides, each shoulder contains five round brilliant cut diamonds, tapering sizes, channel set.



Polished finish, stamped "750, JP88" - acid tested as 18 carat gold. Finger size = Q.

The ring contains;

One illusion claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 4.51mm (average diameter) x 2.75mm (D-estimated)

Total Weight = 0.34ct (estimated - see NOTE below).

Nineteen bead set & channel set (mixed), round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed) medium cut quality.

Dimensions = 1.99mm (average diameter) x 1.21mm (D-estimated) (smallest)

Dimensions = 2.19mm (average diameter) x 1.34mm (D-estimated) (largest)

Total Weight = 0.66ct (estimated - see NOTE below).

Total Item Weight = 5.27 grams, Total Gemstone Weight = 1.00ct, Total Metal Weight = 5.07 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will no be indicative of the resale value of the item.
