### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, platinum, gem set, 'solitaire' style ring, of hand-assembled construction.

Plain, narrow, low half round band of 2.44mm width (at base) x 1.34mm depth, and a curved underrail.

Feature central four claw setting, housing one round brilliant cut diamond, claw set. The setting is secured to the underrail, and in between the extended and pointed shoulders, of the plain and polished band.

Polished finish.

Stamped 'PT 950 HB diamond motif' - acid tested as platinum.

Ring size: G.

The ring contains:

One claw set round brilliant cut diamond, clarity is "Vs2", colour is "F".

Dimensions = 5.94mm(L) x 5.90mm(W) x 3.70mm(D-estimated) x 3.5%(Girdle Thickness)

Total Weight = 0.80ct (known weight - see NOTE below)

Total Item Weight = 4.57 grams

Total Gemstone Weight = 0.80ct

Total Metal Weight = 4.41 grams (estimated)

NOTE: The diamond has been certified by Messrs. Gemological Institute of America (GIA) Certificate number: 2307820818 Dated: Oct. 8, 2018. The diamond has also been laser inscribed upon the girdle with GIA (logo) and 2307820818. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
