## Valuation for Traditional Retail Insurance Replacement

### Item 1

One, lady's 2pce set, hand finished raised, 18ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered bands, measures a combined basal width 4.43mm x 1.26mm depth, with curved underrails.

Feature, "2pce ring set". Comprising, an engagement ring & side band. A raised four claw setting to top, houses one round brilliant cut diamond (laser drilled & fracture filled), claw set. The extended shoulders, the band tapers up. Each shoulder contains, thirty round brilliant cut diamonds, Pave bead set. The complementing side band, containing fifteen round brilliant cut diamonds, in a single row across the top, pave bead set. Polished finish, stamped "750 RT (dia symbol), 18K, 750, 0.18ct" - acid tested both as 18 carat gold. Finger size = N.



The ring set contains;

One claw set round brilliant cut diamond, medium cut quality.

Dimensions = 4.57mm (average diameter) x 2.79mm (D-estimated)

Total Weight = 0.36ct (estimated - see NOTE below).

Seventy Five pave/bead set round brilliant cut diamonds, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 0.90mm (average diameter) x 0.55mm (D-estimated) (smallest)

Dimensions = 1.50mm (average diameter) x 0.92mm (D-estimated) (largest)

Total Weight = 0.48ct (estimated - see NOTE below).

Total Item Weight = 6.59 grams, Total Gemstone Weight = 0.84ct, Total Metal Weight = 6.42 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, the weight of the diamonds is very much an estimation. The central round brilliant cut diamond has been enhanced by means of filling with a glass type substance. This treatment is not stable and can be damaged by heat or ultrasonic frequencies. Due to this filling, colour and clarity gradings have not been assigned. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques with a fractured filled diamond of similar appearance being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
