Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's 2pce set, hand finished raised, 18ct yellow gold & diamond set, multistone rings. Plain, narrow, low half round, tapered band, measures a combined basal width 4.09mm x 1.25mm depth, with curved underrails. Feature, "2pce ring set", an engagement ring, with a contured fitted side band. Comprising, a raised four claw setting to top, houses one round brilliant cut diamond, claw set. The extended shoulders, of the band tapers up, curls & wraps to each side. Containsa total of twenty nine tapered baguette cut diamonds (one chipped), set into four channel settings. The Contured side band, contains twenty seven tapered baguette cut diamonds, channel set.



Polished finish, stamped "750, 750," - acid tested both as 18 carat gold. Finger size = L/K.

The ring set contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "H", medium cut quality.

Dimensions = 4.80mm (average diameter) x 3.15mm (D-estimated)

Total Weight = 0.45ct (estimated - see NOTE below).

Twenty Nine channel set tapered baguette diamonds, clarity is "Si & P1" (mixed), colour is "H to I" (mixed), medium cut quality.

Average dimensions = 1.30mm (L) x 1.10mm (W) x 0.80mm (D-estimated) (smallest)

Average dimensions = 1.50mm (L) x 1.20mm (W) x 0.88mm (D-estimated) (largest)

Total Weight = 0.29ct (estimated - see NOTE below).

Twenty Seven channel set tapered baguette diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Average dimensions = 1.00mm (L) x 0.60mm (W) x 0.44mm (D-estimated) (smallest)

Average dimensions = 1.35mm (L) x 0.75mm (W) x 0.55mm (D-estimated) (largest)

Total Weight = 0.14ct (estimated - see NOTE below).

Total Item Weight = 11.23 grams, Total Gemstone Weight = 0.88ct, Total Metal Weight = 11.05 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamonds cannot be ascertained. Therefore, weight of the diamonds are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamonds, would require removal from the setting. The below replacement figure is based upon crafting a similar 2pce ring set, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
