Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold and 14ct rose gold, gem set, 'cluster' style ring, of cast construction.

Plain, narrow, low half round, tapered band of 1.25mm width (at base) x 1.26mm depth, with a curved underrail.

Feature pear shaped top plate, with a central three claw setting, housing one pear shaped diamond, claw set. Surrounding is two rows of round brillliant cut diamond, claw set. The top plate is secured to the underrail, and in between the upswept shoulders, of the plain and polished band. The surround, gallery, and shoulders are embellished with a total of ninety-five round brilliant cut diamonds, varying in size, and claw set. The gallery houses two rose gold bezel settings, each housing one round ruby, bezel set.



Polished finish. Stamped '14K michael hill 0.87 46628300105' - acid tested as 14 carat gold. Ring size: S.

The ring contains:

One claw set pear shaped diamond, clarity is "Si2", colour is "H".

Dimensions = 6.01mm(L) x 3.71mm(W) x 2.24mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.30ct (estimated - see NOTE below)

Ninety Three claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.52mm(Dia) x 0.93mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.55ct (estimated - see NOTE below)

Two bezel set round rubies, colour is "red".

Dimensions (average) = 1.30mm(Dia) x 0.79mm(D-estimated)

Total Weight = 0.02ct (estimated - see NOTE below)

Total Item Weight = 3.41 grams Total Gemstone Weight = 0.87ct Total Metal Weight = 3.23 grams (estimated)

NOTE: The central diamond has been laser inscribed with "46628300105" and "michael hill". No diamond certificate or paperwork was presented at the time of this valuation. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
