### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 10ct yellow gold and rhodium plated, gem set, multistone ring, of cast construction.

Plain, wide, low half round, tapered band of 4.44mm width (at base) x 1.28mm depth, with a hollow top, open back settings, and a cut out decorative underrail.

Feature rectangle top plate, housing one row of five round brilliant cut diamonds, slightly varying in size, and channel set. The settings are secured between the tapering shoulders, of the plain and polished band, and are framed with one decorative groove to the top and the bottom. Rhodium plating to the diamond setting areas.

Polished finish.

Stamped '10K JST' - acid tested as approximately 10 carat gold.

Ring size: T 1/2.

The ring contains:

- Five channel set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).
- Dimensions = 2.74mm(Dia) x 1.67mm(D-estimated) x 2%(Girdle Thickness) (smallest)
- Dimensions = 3.11mm(Dia) x 1.90mm(D-estimated) x 2%(Girdle Thickness) (largest)
- Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 4.79 grams Total Gemstone Weight = 0.50ct Total Metal Weight = 4.69 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
