Valuation for Traditional Retail Insurance Replacement

Item 1

One, 10ct rose gold, gem set, multi-stone, ring set, of cast construction. The set comprising a 10ct rose gold diamond set engagement ring with a matching 10ct rose gold diamond set wedding ring. Each ring having a plain, narrow, low half round, tapered band with a combined basal width of 3.30mm x 1.21mm in depth. The engagement ring has a diamond shaped top plate, housing a cluster of round brilliant cut diamonds, to the centre, claw set. Surrounding is one row of three tapered baguette cut diamonds, alternating with three round brilliant cut diamonds, graduating in size, and claw set. The top plate is secured between the 'split cross over' style shoulders. The matching wedding ring has one row of twelve single cut diamonds, slightly varying in size, spanning across the top of the band, and claw set. There are a total of twenty-one round brilliant cut diamonds, a total of twelve tapered baguette cut diamonds, and a total of eleven single cut diamonds, claw set. The wedding ring sits alongside the engagement ring above.



Polished finish. Stamped '10KT 0.33 0.04 michael hill' - acid tested as approximately 10 carat gold. Ring size: N 1/2.

Twelve claw set tapered baguette cut diamonds, clarity is "Vs & Si" (mixed), colour is "H".

Dimensions = 2.00mm(L) x 0.90mm(W) x 0.66mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.30mm(L) x 1.10mm(W) x 0.80mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.16ct (estimated - see NOTE below)

Twenty One claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to I" (mixed).

Dimensions = 0.90mm(Dia) x 0.55mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.00mm(Dia) x 1.22mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.17ct (estimated - see NOTE below)

Eleven claw set single cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "H to J" (mixed).

Dimensions = 0.80mm (diameter) (smallest)

Dimensions = 1.00mm (diameter) (largest)

Total Weight = 0.04ct (estimated - see NOTE below)

Total Item Weight = 4.53 grams Total Gemstone Weight = 0.37ct Total Metal Weight = 4.46 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
