Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand-finished raised, 9ct yellow and white gold, diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 1.87mm width 9at base) x 1.16mm depth, with curved underrail.

Feature, "cluster style" ring design. Comprising, a three tier step down, square cushion-shaped cluster setting in white gold. The extended shoulders, of the yellow gold band, tapers up to pointed end terminations to both sides.

Polished finish, unstamped - acid tested as 9 carat gold. Finger size = T.

The ring contains;

Four claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 1.75mm (average diameter) x 1.07mm (D-estimated)
Total Weight = 0.08ct (estimated - see NOTE below).

Forty claw set single cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.
Dimensions = 0.85mm (average diameter) (smallest)
Dimensions = 1.00mm (average diameter) (largest)
Total Weight = 0.20ct (estimated - see NOTE below).

Total Item Weight = 2.80 grams, Total Gemstone Weight = 0.28ct, Total Metal Weight = 2.74 grams (estimated)

NOTE: Limited gemological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
