Valuation for Traditional Retail Insurance Replacement


Item 1

One, lady's, hand-finished raised, 9ct yellow and white gold & diamond set, cluster ring. Plain, narrow, low half round, tapered band, measures 2.33mm width (at base) x 0.87mm depth, with curved underrail.

Feature, "raised cluster setting" in white gold, houses seven round brilliant cut diamonds, claw set. The extended shoulders, tapers up to the top, split to the side. Each shoulder contains four round brilliant cut diamonds, channel set.

Polished finish, stamped "MHJ 9ct.30D" - acid tested as 9 carat gold. Finger size = K.

The ring contains;



Eight channel set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality. Dimensions = 1.30mm (average diameter) x 0.79mm (D-estimated) Total Weight = 0.08ct (estimated - see NOTE below).

Total Item Weight = 2.80 grams, Total Gemstone Weight = 0.30ct, Total Metal Weight = 2.74 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
