## Valuation for Traditional Retail Insurance Replacement

## Item 1

One, lady's, hand-finished raised, 18ct yellow and white gold multistone ring. Plain, narrow, flat, tapered band. measures 2.38mm width (at base) x 0.86mm depth, with curved underrail.

Feature, "cluster style" ring design, with shoulder stones, Comprising, a teir step down cluster setting, in white gold. The extended shoulders, of the yellow gold band, tapers up splits to the side pointed end terminations. a channel row to each base.

Polished finish, stamped "750, .32DL" - acid tested as 18 carat gold. Finger size M.



The ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "H to I"(mixed), medium cut quality. Dimensions = 4.10mm (average diameter) x 2.50mm (D-estimated) x 2%(Girdle Thickness) Total Weight = 0.25ct (estimated - see NOTE below).

Eight channel set round brilliant cut diamonds, clarity is "Si", colour is "H to I"(mixed), medium cut quality. Dimensions = 1.30mm (average diameter) x 0.79mm (D-estimated)

Total Weight = 0.08ct (estimated - see NOTE below).

Total Item Weight = 3.50 grams, Total Gemstone Weight = 0.33ct, Total Metal Weight = 3.43 gram (estimated)

NOTE: Limited germological testing, inset. Due to setting constraints, the exact dimensions of the germstones cannot be ascertained. Therefore, weights of the germstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the germstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
