Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, multistone, gem set ring, of cast construction.

Plain, narrow, tapered band of 6.27mm at top to 2.41mm in width (at base) x 0.85mm depth, with hollow top and shoulders, and open back settings.

Feature three row ring design, having thirteen round brilliant cut diamonds, channel set to the centre row. The outside rows, each having thirteen single cut diamonds, bead set.

Polished finish.

Stamped '375 GM16' - acid tested as 9 carat gold.

Finger size is O.

The ring contains:

Thirty Nine channel set & bead set (mixed) round brilliant cut & single cut (mixed) diamonds, clarity 'Si, P1, P2 & P3' (mixed), colour 'G to I' (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.45mm(Dia) x 0.88mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.50ct (estimated - see NOTE below)

Total Item Weight = 2.60 grams

Total Gemstone Weight = 0.50ct

Total Metal Weight = 2.50 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
