Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand finished, raised 18ct white gold & diamond set, solitaire style ring. Plain, narrow, low half round, tapered band, measures, 2.29mm width (at base) x 0.99mm depth, with curved underrail, & undercarriage side stones.

Feature, "solitaire style" ring design, with undercarriage side stones. The extended shoulders, of the band, tapers up to the top, from both sides, with pointed end terminations, to both sides.

Polished finish, stamped "18K" - acid tested as 18 carat gold.

Finger size = O.

The ring contains;

One claw set round brilliant cut diamond, clarity is "P1", colour is "I", medium cut quality.

Dimensions = 3.74mm (Diameter) x 2.28mm (D-estimated)

Total Weight = 0.18ct (estimated - see NOTE below).

Four rub-over set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.

Dimensions = 1.00mm (Diameter) x 0.61mm (D-estimated)

Total Weight = 0.02ct (estimated - see NOTE below).

Total Item Weight = 2.60 grams, Total Gemstone Weight = 0.20ct, Total Metal Weight = 2.56 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
