Valuation for Traditional Retail Insurance Replacement

Item 1

One lady's, 3pce set (fused together), hand-assembled raised, yellow gold (mixed), & gemstone set (mixed) multistone ring, Plain, combined basal width 4.72mm x 0.87mm depth. low half round, tapered band.

Feature, "3pc ring set" fused together, The centre band having a single row, alternating, with four claw settings, across the top. Open back settings, underneath. Two plain, polished bands, one to each side.

Polished finish, stamped "9ct CG, 18ct"(mixed) - acid tested & x-rayed.

Finger size = P1/2.

The ring contains;

Three claw set round natural sapphires, colour is "dark - blue".
Dimensions = 3.09mm (Diameter) x 1.88mm (D-estimated)
Total Weight = 0.39ct (estimated - see NOTE below).

Two claw set round brilliant cut diamonds, clarity is "Si", colour is "G to H"(mixed), medium cut quality.
Dimensions = 3.17mm (average diameter) x 1.93mm (D-estimated) (smallest)
Dimensions = 3.25mm (average diameter) x 1.98mm (D-estimated) (largest)
Total Weight = 0.26ct (estimated - see NOTE below).

Total Item Weight = 7.67 grams, Total Gemstone Weight = 0.65ct, Total Metal Weight = 7.54 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar 3pce ring set (fused together) employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
