Valuation for Traditional Retail Insurance Replacement

Item 1

One, pair of hand-assembled raised, 14ct white gold & diamond set, drop pierced earrings.

Feature, 'drop style' earrings. Each comprising, a zig/zag pattern to front, housing six round brilliant cut diamonds, claw set, open back settings, underneath, Fitted to top plain post, hinged to bottom with a split open clip to back.

Polished finish, stamped "10 centurian head 585" - acid tested as 14 carat gold.

Earring dimensions = 19.44mm (length) x 6.68mm (width) x 2.70mm (depth).

The earrings contain:

Twelve claw set round brilliant cut diamonds, clarity is "Si & P1"(mixed), colour is "H to I"(mixed), medium cut quality.

Dimensions = 2.29mm (average diameter) x 1.40mm (D-estimated) (smallest)

Dimensions = 2.45mm (average diameter) x 1.49mm (D-estimated) (largest)

Total Weight = 0.54ct (estimated - see NOTE below).

Total Item Weight = 4.22 grams, Total Gemstone Weight = 0.54ct, Total Metal Weight = 4.11 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pair of earrings, employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
