Valuation for Traditional Retail Insurance Replacement

Item 1

One, 14ct white gold and 14ct rose gold pendant, gem set, pendant of hand-assembled construction.

Feature white gold 'infinity' style pendant, embellished with a rose gold flat wire vertically down the centre. There is one four claw setting, housing one round brilliant cut diamond, claw set. Radiating out from the central setting, is one row of ten baguette cut diamonds, channel set. There is also one row of thirteen round brilliant cut and single cut diamonds, and one synthetic cubic zirconia, claw set. The pendant is finished with an articulated tapered bail.

Pendant dimensions= 47.90mm (ave. length) x 17.50 (ave. depth) x 6.10mm (ave. depth).
Polished finish. Unstamped - acid tested as approximately 14 carat gold.

The pendant contains:

One claw set round brilliant cut diamond, clarity is "P2", colour is "J".

Dimensions = 5.41mm(L) x 5.38mm(W) x 3.58mm(D-estimated) x 3%(Girdle Thickness)

Total Weight = 0.65ct (estimated - see NOTE below)

Thirteen claw set round brilliant cut diamonds, clarity is "Si & P1 & P2" (mixed), colour is "I to J" (mixed) and one claw set round synthetic cubic zirconia, colour is "colourless".

Dimensions = 1.60mm(Dia) x 0.98mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 1.83mm(Dia) x 1.12mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.34ct (estimated - see NOTE below)

Ten channel set tapered baguette cut diamonds, clarity is "P1 & P2" (mixed), colour is "I to J" (mixed).

Dimensions = 2.44mm(L) x 1.04mm(W) x 0.76mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.82mm(L) x 1.13mm(W) x 0.82mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.14ct (estimated - see NOTE below)

Two channel set Princess cut diamonds, clarity is "P2 & P3" (mixed), colour is "I to J" (mixed).

Dimensions (average) = 2.00mm(L) x 2.00mm(W) x 1.42mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.10ct (estimated - see NOTE below)

Total Item Weight = 7.35 grams Total Gemstone Weight = 1.23ct Total Metal Weight = 7.10 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
