### Valuation for Traditional Retail Insurance Replacement

#### Item 1

One, 14ct white gold, gem set, pendant, of hand-assembled construction.

Feature one vertical row of six oval natural sapphires, end set. Surrounding is one row of forty-two round brilliant cut diamonds, creating a 'scalloped' edge, and bead set. There is a pierced panel to the reverse, enclosing the settings. The pendant is finished with an articulated tapered bail.

Pendant dimensions = 38.50mm (ave. length) x 8.30mm (ave. width) x 3.39mm (ave. depth).

Polished finish. Stamped '14K MRB' - acid tested as 14 carat gold.

The pendant contains:

Six end set set oval shaped natural sapphires, colours are "purple, orange, yellow, blue, green".

Dimensions (average) = 4.11mm(L) x 3.2mm(W) x 1.58mm(D-estimated)

Total Weight = 1.01ct (estimated - see NOTE below)

Forty Two bead set round brilliant cut diamonds, clarity is "Si", colour is "G to H" (mixed).

Dimensions (average) = 1.04mm(Dia) x 0.63mm(D-estimated) x 2%(Girdle Thickness)

Total Weight = 0.21ct (estimated - see NOTE below)

Total Item Weight = 3.21 grams Total Gemstone Weight = 1.22ct Total Metal Weight = 2.97 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar pendant employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
