Valuation for Traditional Retail Insurance Replacement

Item 1

One, 9ct white gold, multistone, ring set, of cast construction.

The set comprising a 9ct white gold, diamond set engagement ring, with a fitted and matching 9ct white gold diamond set wedding ring. Each ring having a plain, narrow, tapered band with a combined basal width of 2.95mm x 0.90mm in depth.

The engagement ring has a multi-claw setting, housing three round brilliant cut diamonds, slightly tapering in size, claw set. Secured in the 'wrap-around' style, extended shoulder of the plain and polished band. The opposite shoulder of a 'cross-over' design.



Fitted and matching wedding ring, having an extended 'wrap-around' shoulder, housing six round brilliant cut diamonds, also slightly tapering in size, channel set. The wedding ring sits alongside the engagement ring above.

Polished finish - stamped '9K' - acid tested as 9 carat gold. Finger size is R.

The ring contains:

Nine claw set & channel set (mixed) round brilliant cut diamonds, clarity 'P1 to P3' (mixed), colour 'I to J' (mixed).

Dimensions = 1.30mm(Dia) x 0.79mm(D-estimated) x 2%(Girdle Thickness) (smallest)

Dimensions = 2.20mm(Dia) x 1.34mm(D-estimated) x 2%(Girdle Thickness) (largest)

Total Weight = 0.18ct (estimated - see NOTE below)

Total Item Weight = 4.63 grams - Total Gemstone Weight = 0.18ct - Total Metal Weight = 4.59 grams (estimated)

NOTE: Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring set employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
