
Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, hand-assembled raised, 18ct yellow gold & diamond set, multistone ring. Plain, narrow, flat, tapered band, measures 2.39mm width 9at base) x 0.90mm depth, with curved underrail.

Feature, "random cluster style" with shoulder stones. Comprising, four raised multi level four claw settings. The extended shoulders, of the band, tapers up to pointed end terminations to both sides.

Polished finish, stamped "750, (T)" - acid tested as 18 carat gold. Finger size = N.



Four claw set round brilliant cut diamonds, clarity is "Si", colour is "I to J"(mixed), medium cut quality.

Dimensions = 2.25mm (average diameter) x 1.37mm (D-estimated) (smallest)

Dimensions = 2.48mm (average diameter) x 1.51mm (D-estimated) (largest)

Total Weight = 0.20ct (estimated - see NOTE below).

Six bead set single cut diamonds, clarity is "Si & P1"(mixed), colour is "I to J"(mixed), medium cut quality.

Dimensions = 1.30mm (average diameter)

Total Weight = 0.05ct (estimated - see NOTE below).

Total Item Weight = 3.00 grams, Total Gemstone Weight = 0.25ct, Total Metal Weight = 2.95 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
