Valuation for Traditional Retail Insurance Replacement

Item 1

One, lady's, 2pce ring set (fused), hand-assembled raised, 18ct white gold & diamond set, multistone ring. Plain, narrow, low half round, tapered band, measures 2.89mm width (at base) x 0.83mm depth, with curved underrail.

Feature, "2pce ring set" (fused), together. Comprising, a raised six claw setting, houses one round brilliant cut diamond, claw set. Flanked to each side, one four claw setting, contains one single cut diamond, claw set. The extended shoulders, of the band tapers up to the top. A contoured fitted plain side band, fused to one side.

Polished finish, stamped "750" - acid tested as 18 carat gold. Finger size = P1/2.

the ring contains;

One claw set round brilliant cut diamond, clarity is "Si", colour is "G", medium cut quality.
Dimensions = 3.58mm (Diameter) x 2.18mm (D-estimated)
Total Weight = 0.17ct (estimated - see NOTE below).

Two claw set single cut diamonds, clarity is "Si", colour is "H", medium cut quality.
Dimensions = 1.12mm (average diameter)
Total Weight = 0.01ct (estimated - see NOTE below).

Total Item Weight = 5.30 grams, Total Gemstone Weight = 0.18ct, Total Metal Weight = 5.26 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the gemstones cannot be ascertained. Therefore, weights of the gemstones are very much estimated. For accurate testing, weights, colour, and clarity gradings, the gemstones require removal from the settings. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
