Valuation for Traditional Retail Insurance Replacement

Item 1

One gents, hand finished, raised, 18ct yellow gold & diamond set, dress ring. Plain, wide, flat, tapered band, measures 3.92mm width (at base) x 0.71mm depth, tapers up to 7.69mm width (at top), with curved underrail, open back setting, underneath.

Feature, "wide style" band. Comprising, fluted edge to both sides, to centre top, housing one round brilliant cut diamond, rub-over set, flush to band. The extended shoulders, taper wide to top, both sides.

Polished finish, unstamped - acid tested as 18 carat gold.

Finger size = X.

The ring contains;

One rub over set round brilliant cut diamond, clarity is "Si2", colour is "G", medium cut quality.
Dimensions = 3.28mm (Diameter) x 2.09mm (D-estimated)
Total Weight = 0.14ct (estimated - see NOTE below).

Total Item Weight = 8.10 grams, Total Gemstone Weight = 0.14ct, Total Metal Weight = 8.07 grams (estimated)

NOTE: Limited gemmological testing, inset. Due to setting constraints, the exact dimensions of the diamond cannot be ascertained. Therefore, weight of the diamond are very much estimated. For accurate testing, weights, colour, and clarity gradings, the diamond, would require removal from the setting. The below replacement figure is based upon crafting a similar ring employing similar materials and techniques being for a retail insurance purpose only. This figure does not represent the previous selling price of the item and will not be indicative of the resale value of the item.
