

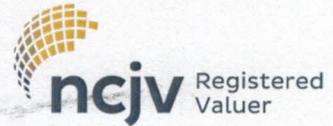

CERTIFICATE OF VALUATION



Description: A ladies stamped 18k 750 GFC white gold seventy one diamond ring. The central diamond is invisibly set with surrounding diamonds two claw chener set in a cluster. Diamonds are bead set surrounding and two claw set either side. The cut out patterned, flared design shoulders contain four claw set diamonds, set along the outer edges. Diamonds are bead set in the sides of the central setting. The ring is of cast manufacture. Ring Size: T.

Measurements:

- 1 x Diamond – round brilliant cut, 3.1mm, estimated weight 0.11ct, Clarity VS, Colour G-I.
- 6 x Diamonds – round brilliant cut, 2.2mm, estimated weight 0.04ct each, Clarity VS, Colour G-I, one is chipped.
- 12 x Diamonds – round brilliant cut, 1.4mm, estimated weight 0.01ct each, Clarity VS, Colour G-I.
- 28 x Diamonds – round brilliant cut, 1.0mm to 1.1mm, estimated weight 0.004ct each, Clarity VS, Colour G-I.
- 16 x Diamonds – round brilliant cut, 1.2mm to 1.3mm, estimated weight 0.007ct each, Clarity VS, Colour G-I.
- 4 x Diamonds – single cut, 1.0mm to 1.1mm, estimated weight 0.004ct each, Clarity SI-P1, Colour H-J.

Due to the stones being set the weight, clarity and colour are estimated.
Total Diamond Weight: 0.71ct.
Total Weight: 4.20 grams.
